After the Career coach course, we will discuss with students and mentors, and divide the company into 3 tiers according to the background of the students, and the online application ratio from each tier will be adjusted according to the situation of the students.

Yes, all of the tutors have more than 10 years of working experience in the Aussie local companies. The senior industry instructor will deep dive

into the student background and give different career path development

suggestions; after that, the general career mentor will establish students

with their Personal Branding (resume remodification / cover letter / LinkedIn), interview skills, mock interviews, and help students understand

the Australian workplace culture.
